*National Rationale*

*The Pupil Premium is a Government initiative that targets extra money at pupils who come from backgrounds that might be deemed to be disadvantaged. The premium is provided in order to support these pupils so they may reach their potential.*

*Eligibility for the Pupil Premium from April 2012 is for any pupil who has been entitled to Free School Meals (FSM) in the last six years. In addition, pupils who are "looked after" by the authority (LAC) or whose parents are currently serving in the armed forces are also entitled to the premium.*

*From April 2014, schools in England can receive the Pupil Premium for children adopted from care, or who left care under a Special Guardianship Order on or after 30 December 2005. Schools can also claim the Pupil Premium for children who left care under a Residence Order on or after 14 October 1991.*

*The Government believes that the Pupil Premium is the best way to address the current underlying inequalities for disadvantage pupils.*

*Each individual school is held accountable for how they use their Pupil Premium allocation in order that the funding is targeted towards those pupils who need it most. It is for schools to decide how the Pupil Premium is spent, since they are best placed to*

*assess what additional provision should be made for the individual pupils within their settings.*

*At St Catherine's our Key objective in using the Pupil Premium Funding*

- *To narrow the gap between vulnerable groups.*
- *To enable pupils to gain from the whole school experience and opportunities on offer*

*At St Catherine's we provide a culture where:*

- *All children are valued*
- *All staff believe each child can reach their potential.*
- *Staff adopt an outcome focussed approach to overcome barriers to learning or to further challenge our children*
- *All staff support children to be the best that they can*

*How:*

*At St Catherine's we ensure that all pupils reach their potential but with special care for those most vulnerable:*

- *All class teachers are involved in the analysis of data, receive important information about our all our pupils and their needs and contribute to the identification and intervention.*
- *All class teachers are involved in the moderation of attainment and are all fully aware of the progress and attainment of pupils through tracking ,pupil progress meetings and intervention reviews*
- *All staff are aware of who are our disadvantage pupils ,pupils are identified through specific markings on their books pertaining to a particular group which they may belong to*
- *All disadvantaged pupils benefit from the funding ,not just those children who are underperforming or of a lower ability*
- *Underachievement at all levels is targeted, again not just for those who are underperforming or of lower ability*
- *Underachievement at all levels is targeted*

*At St Catherine's we continue to ensure our Teaching and Learning is good or better by asking staff to:*

- *Have high expectations*
- *Be good role models*
- *Ensure consistent implementation of the non –negotiables eg Marking and Feedback Policy The Choices Behaviour Policy*

- *Strive to be reflective and improve our practice*
- *Improve assessment through joint levelling and moderation*
